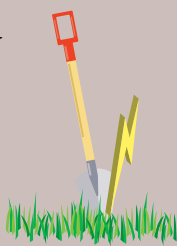




Dial Before Digging

You never really know what's below the surface when you dig. You may chop right into underground power lines. In addition to causing outages, this is very dangerous. Before digging in your yard, have the underground electric lines located. Please give us three days notice before you dig. Call us at (252) 426-5735.



Transformers Overgrown

Homeowners are being advised not to plant vegetation around transformers in their yards.

Ground transformers are green, metal boxes located in front of homes that are in neighborhoods with underground power lines.

Some homeowners have planted trees and shrubs to screen the transformers. Because this creates a safety issue, Albemarle EMC will begin notifying homeowners that they need to remove vegetation within 10 feet of the side of the transformer that opens and three feet around all other sides. If the vegetation is not removed within 30 days, Albemarle EMC will remove the vegetation.

Public Weatherization Assistance Available

For those who may struggle with heating bills this winter, there is a chance that you may qualify for public assistance.

The Economic Improvement Council (EIC), a nonprofit agency based in Edenton, N.C., will be receiving a sizeable amount of stimulus money, said Fentress Morris, the council's executive director.

"We should be receiving \$279,000 in the first phase of stimulus money," Fentress said.

Individuals who qualify can receive up to \$4,000 worth of work to have their house weatherized. The work includes air sealing, attic insulation and blower-door tests, which test the house for air leaks. The Economic Improvement

Council's own crew does all of the work except for HVAC work.

AEMC Committed to Environmental Stewardship

With deep roots in the agricultural community, it should come as no surprise that Albemarle EMC is committed to sound stewardship of our natural resources.

A recent example of this commitment is the implementation of energy efficiency programs that will reduce the need for generation. In 2009, Albemarle EMC began selling hot water heater blanket kits at below cost. The kits result in a savings of 807 kWh per blanket per year. Also, members are being sent a two-pack of compact fluorescent bulbs (CFLs). By replacing low-efficiency incandescent light bulbs with high efficiency CFLs, a member can save 48.9 kilowatt hours (kWh) per pack of bulbs per year.

CFL Recycling

In addition, the co-op recently contracted with a company that recycles used CFLs. Members who have unbroken CFLs they wish to discard can bring those

bulbs to the co-op's office, located at 159 Creek Drive, Hertford, where they will be safely stored for future recycling.

The bulbs are stored in a sealed 10-gallon bucket. Once the bucket is full, it is shipped to the recycling company. The mercury vapor, glass, aluminum end caps and phosphorous are all separated for later reuse.

The glass is used for sand blasting and is also used in reflective paint. The mercury vapor goes back into new bulbs. The aluminum is used for non-food containers.

Utility Poles

One of the less noticeable parts of our recycling effort is poles. Whenever we have damaged poles that need to be taken off the line, we bring them back to the cooperative's office and sell them for 40 cents a foot. Obviously these used poles are not a substantial revenue stream, but the practice does enable the poles to be put to good use instead of going into a landfill.

Shredded Documents

Long gone are the days when a company's documents safely could be disposed of at a landfill. With identity theft on the rise, outdated documents must be destroyed prior to disposal. We accomplish that task by utilizing a company that specializes in on-site destruction of documents. A truck with an onboard industrial shredder converts our old paper documents into tiny paper particles, which are then recycled back into new paper products.

Right-of-Way Spraying

One of the methods we employ to keep our right-of-ways clear is the use of spray chemicals. Spraying promotes wildlife habitat more effectively than conventional cutting. The reason is that spraying eliminates the tall-growing woody vegetations that can interfere with power lines and shade out beneficial plants that provide good habitat for wildlife. We use a variety of spray chemicals that are wildlife friendly and even recommended by organizations such as Quail Unlimited.

Bright Ideas

Albemarle EMC awards grants to teachers. Often these grants go to fund environmental projects around the school.

One grant was recently used to fund the creation of a system that conveys heat from a greenhouse to a classroom in John A. Holmes High School, in Edenton. The system essentially provides heat that does not require the generation of electricity. Grants have also been used to fund the creation of school wetland projects.

A Green Company

When Albemarle EMC says it is a community-minded company, that philosophy includes the environment we all share. By supporting clean energy, recycling waste material, using wildlife friendly herbicides and taking other measures, we do our small part toward creating a healthier community. Not only is it good business; it's the right thing to do.
